On March 18, 2024, the highest price at which shares were sold was \$17.80, and the lowest price at which shares were sold was \$17.60. On March 12, 2024, the Reporting Person filed with the Securities and Exchange Commission a Form 144 covering the sale of the Issuer's common stock reported in Table I.
